We refer to the letter from PT Bursa Efek Indonesia ("IDX") No. S-14643/BEI.PP2/12-2025 dated 30 December 2025 on IDX Queries. PT Wijaya Karya (Persero) Tbk ("Company") wishes to inform and clarify the following:

**1. Background of the PKPU petition filed by PT Abacurra Indonesia against the Company**

The Company still has outstanding payments to PT Abacurra Indonesia ("Petitioner") for work on an ongoing project. The outstanding payments are divided into instalments with a total amount of Rp1,513,320,718, of which the Company has paid Rp718,827,340.

**2. The value of the petition and the Company's assessment of its materiality**

The value of the petition for the remaining work is Rp794,493,378 and is not material to the Company.

**3. Impacts of the PKPU petition to the Company's financial performance and operational activities**

The PKPU petition does not impact the Company's financial performance and operational activities.

**4. Current updates regarding the PKPU petition**

The first hearing was held on Monday, 29 December 2025 under case number 406/Pdt.SusPKPU/2025/PN.Niaga.Jkt.Pst. The next hearing will be held on Monday, 5 January 2026 with the agenda of Document Legality Verification.

**5. Efforts to resolve the PKPU petition**

The Company continues to communicate with PT Abacurra Indonesia and undergo legal processes in accordance with applicable laws.
