the General Meeting of Bondholders of the Wijaya Karya Shelf Registration Bond I Phase II Year 2021 (“**RUPO**”) was convened.

The RUPO Agenda was as follows:

Approval to waive the financial covenants of PT Wijaya Karya (Persero) Tbk., as stipulated in Article 6 section 6.3 subsection m of the Trustee Agreement for the Wijaya Karya Shelf Registration Bond I Phase II Year 2021, Deed No. 11 dated 8 February 2021, made before Ir. Nanette Cahyanie Handari Adi Warsito, S.H., a Notary in Jakarta, for the annual consolidated financial statement for the period ending on 31 December 2023.

The RUPO was attended by holders and/or their valid proxies of the Wijaya Karya Shelf Registration Bond I Phase II Year 2021 (“**Bondholders**”) of the Wijaya Karya Shelf Registration Bond I Phase II Year 2021 (“**Bond**”), holding in aggregate **Rp2,259,700,000,000** (two trillion two hundred fifty-nine billion seven hundred million Rupiah), or **2,259,700,000,000** (two trillion two hundred fifty-nine billion seven hundred million) votes, or **90.75%** (ninety point seven five percent) of the outstanding Bonds (including Bonds held by Affiliated Companies arising due to capital ownership or investment by the Government, but excluding Bonds held by the Company and/or its Affiliates) from a Principal Amount of **Rp2,500,000,000,000 (two trillion five hundred billion Rupiah)** less Rp10,000,000,000 (ten billion Rupiah) of the Bond held by Affiliated Companies or equal to **Rp2,490,000,000,000 (two trillion four hundred ninety billion Rupiah)**. Therefore, the RUPO has met the attendance quorum as specified in Article 10 section 10.6 of subsection a paragraph (i) of the Trustee Agreement for the Wijaya Karya Shelf Registration Bond I Phase II Year 2021, Deed No. 11 dated 8 February 2021, made before Ir. Nanette Cahyanie Handari Adi

Warsito, S.H., a Notary in Jakarta, and its amendments (“**Trustee Agreement**”). Accordingly, the RUPO is valid and is entitled to adopt legal and binding resolutions for Bondholders.

The RUPO convened at 17.26 WIB (Western Indonesia Time).

The resolution of the RUPO Agenda was adopted by means of voting:

- Total valid votes present at the RUPO were 2,259,700,000,000 (two trillion two hundred fifty-nine billion seven hundred million) votes, or representing Bondholders holding an aggregate sum of Rp2,259,700,000,000 (two trillion two hundred fifty-nine billion seven hundred million Rupiah).
- The total abstention votes were 139,000,000,000 (one hundred thirty-nine billion) votes or representing Bondholders holding an aggregate sum of Rp139,000,000,000 (one hundred thirty-nine billion Rupiah). Pursuant to Article 10 section 10.4 subsection I of the Trustee Agreement, Bondholders voting to abstain are deemed to not have voted. Thus, the total votes casted was 2,120,700,000,000 (two trillion one hundred twenty billion seven hundred million) votes or representing Bondholders holding an aggregate sum of Rp2,120,700,000,000 (two trillion one hundred twenty billion seven hundred million Rupiah).
- The total negative votes rejecting the proposal presented by PT Wijaya Karya (Persero) Tbk. as the Issuer in the RUPO on 28 November 2023 were 283,000,000,000 (two hundred eighty-three billion) votes or representing Bondholders holding an aggregate sum of Rp283,000,000,000 (two hundred eighty-three billion Rupiah).
- The total affirmative votes approving the proposal presented by PT Wijaya Karya (Persero) Tbk. as the Issuer in the RUPO on 28 November 2023 were 1,837,700,000,000 (one trillion eight hundred thirty-seven billion seven hundred million) votes or representing Bondholders holding an aggregate sum of Rp1,837,700,000,000 (one trillion eight hundred thirty-seven billion seven hundred million Rupiah) or 86.66% (eighty-six point six six percent).

Consequently, pursuant to the decision-making quorum in the RUPO, **Bondholders in the RUPO have approved the proposal presented by PT Wijaya Karya (Persero) Tbk. as the Issuer in the RUPO, as follows:**

- I. Approved to waive the financial covenants of PT Wijaya Karya (Persero) Tbk. as stipulated in Article 6 section 6.3 subsection m of the Trustee Agreement, as follows:
 - a. to maintain Current Assets and Current Liabilities ratio of not less than 100% (one hundred percent)
 - b. to maintain interest bearing debt-to-equity ratio of not more than 2.50x (two point five zero times)
 - c. to maintain EBITDA to loan interest expense ratio of not less than 1.00x (one point zero times)for the annual consolidated financial statement of PT Wijaya Karya (Persero) Tbk. ending on 31 December 2023.
- II. In view of the results of the RUPO held on 28 November 2023, Bondholders approved to grant power and authority to PT Bank Mega Tbk. as the Trustee to: move and sign the

amendments/addendum of the Trustee Agreement as well as its amendments and other related agreements (if any); to move the amendments and/or supplement the provisions contained in the Trustee Agreement; and to take any actions related thereto, including but not limited to appear before a Notary and sign the amendment/addendum of the agreements in order to carry out the resolution of the RUPO held on 28 November 2023.

- III. The Bondholders and PT Wijaya Karya (Persero) Tbk. as the Issuer hereby ratify and unconditionally accept every action of the Trustee as an action by the Bondholders themselves. Therefore, the Bondholders and PT Wijaya Karya (Persero) Tbk. hereby expressly release PT Bank Mega Tbk. as Trustee, the Notary, and witnesses from any claims, indictment and/or civil or criminal lawsuits from any party, including but not limited to in connection with the administration and/or resolutions of the RUPO held on 28 November 2023.
- IV. In accordance with the provisions of Article 10 of the Trustee Agreement, all costs arising from convening the RUPO, including the costs of announcement, invitation, Notary, and other costs in connection with the administration and arrangement of the RUPO held on 28 November 2023, are borne by PT Wijaya Karya (Persero) Tbk. as the Issuer.

The RUPO was adjourned at 18.27 WIB.

The Resolutions of this RUPO is stated in the Deed of the Meeting Number 57 dated on this day, Tuesday, 28 November 2023 and made by I, the Notary.
