Signed in Senegal, the contract for the project's first phase is worth €50 million from a total value of €250 million. <p>The project is a tangible follow-up to the business deals made between the Senegalese Government with the Company and the Indonesia Eximbank (<i>Lembaga Pembiayaan Ekspor Indonesia</i>, LPEI) during the Indonesia-Africa Infrastructure Dialogue (IAID) held in August 2019. To undertake the project, the Company has obtained a financing facility using the National Interest Account (NIA) under the Buyer's Credit scheme provided by the LPEI.</p>
